

## The Ultimate Family Sweepstakes

### Official Rules

April 11, 2016 - May 26, 2016

**PRELIMINARY INFORMATION:** NO PURCHASE NECESSARY. A purchase will not improve your chances of winning. Void where prohibited. The Ultimate Family Sweepstakes (“Sweepstakes”) will begin on April 11, 2016 at 12:00 AM ET and end on May 26, 2016 at 7:00 PM ET (“Sweepstakes Period”). All times in the Sweepstakes refer to Eastern Time (“ET”). Odds of winning depend upon the number of eligible Entries received. Sweepstakes is subject to all applicable federal, state and local laws.

**ELIGIBILITY:** Open only to permanent, legal United States (“U.S.”) residents who are physically residing in one (1) of the fifty (50) United States or District of Columbia (excluding Puerto Rico, Guam, the U.S. Virgin Islands and other United States territories), and who are eighteen (18) years of age or older and of the age of majority in their state of residence as of the start of the Sweepstakes Period. Officers, directors, and employees of Sweepstakes Entities (as defined below), members of these persons’ immediate families (spouses and/or parents, children, and siblings, and each of their respective spouses, regardless of where they reside), and/or persons living in the same households as these persons (whether or not related thereto) are not eligible to enter or win the Sweepstakes. Sweepstakes Entities, as referenced herein, shall include NBCUniversal Media, LLC, 30 Rockefeller Plaza, New York, NY 10112 (“Sponsor”), and each of its respective parent, subsidiary, and affiliate companies, dealers, distributors, and administrative, advertising, and promotion agencies, and any other entity involved in the development, administration, fulfillment, promotion, or implementation of the Sweepstakes.

**HOW TO ENTER:** The Sweepstakes will consist of seven (7) individual weekly drawings (each a “Weekly Drawing”). Each Weekly Drawing will consist of (i) an entry period (a “Weekly Entry Period”) that will begin at a specified time (each a “Weekly Entry Period Start Time”) as detailed in the chart below and will end at a specified time (each a “Weekly Entry Period End Time”) as detailed in the chart below and (ii) a random Weekly Drawing conducted on the weekly drawing date (“Weekly Drawing Date”) specified in the chart below from among all eligible Entries (defined below) received during such Weekly Entry Period. Entries must be received before the end of the Weekly Entry Period to be eligible for the corresponding Weekly Drawing. There will be a total of three hundred and fifty (350) Winners (defined below) selected throughout the Sweepstakes Period as detailed below. Note: Weekly Entry Periods may not consist of seven (7) days.

To enter the Sweepstakes, during the Sweepstakes Period go to [www.twitter.com](http://www.twitter.com), (“Twitter Site”) and (1) if you already have a Twitter account, log on using your Twitter user name and password, (2) if you do not already have a Twitter account, create a free Twitter account according to the instructions on the Twitter Site. Please note that you must agree to comply with the Twitter Terms of Use in order to create a Twitter account. twenty four (24) hours of the Weekly Entry Period Start Time (the “Announcement”), and you will be required to submit a Retweet of the Announcement with the hashtag “#PacificaPetsSweepstakes” OR create an original tweet with the hashtag #PacificaPetsSweepstakes and share the custom video content. You must include "#PacificaPetsSweepstakes" in your Entry or your Entry will not be valid. **If your Twitter profile is set to the “Protect my Tweets” setting, your Entry may be disqualified and rejected as ineligible for consideration in the Sweepstakes. If you choose to submit a Twitter Entry via your web-enabled mobile device, data rates may apply. See your wireless service provider for details on rates and capabilities.**

All Entries become the property of Sponsors and will not be acknowledged.

**You may enter one (1) time per day for a maximum of thirty-four (34) Entries during the entire Sweepstakes Period. Non-winning Entries from the previous Weekly Entry Period will roll into subsequent Weekly Drawings.** Multiple Entries received from any person beyond this limit will void all such additional Entries. Entries must be received before May 26, 2016 at 7:00:00 PM ET to be eligible for the Sweepstakes. Sponsors’ computer shall be the official timekeeper for all matters related to this Sweepstakes. For the purposes of these Official Rules a “day” will start at 12:00:00AM ET and end at 11:59:59 PM ET, with the exception of 5/26/16 which ends at 7:00 PM ET. Entries generated by a script, macro, or other automated means or by any means that subverts the entry process will be disqualified. Entries that are incomplete, garbled, corrupted, or unintelligible for any reason, including, but not limited to, computer or network malfunction or congestion, are void and will not be accepted. In case of a dispute over the identity of an entrant, the authorized account holder of the Twitter account used to enter will be deemed to be the entrant. “Authorized account holder” is defined as the person who is assigned to a Twitter account by the Twitter Site. Entry constitutes permission (except where prohibited by law) to use entrant’s name, Twitter user name, city, state, likeness, image, and/or voice for purposes of advertising, promotion, and publicity in any and all media now or hereafter known, throughout the world in perpetuity, without additional compensation, notification, permission, or approval.

**WINNER SELECTION AND NOTIFICATION:** On or about each Weekly Drawing Date, fifty (50) potential winners (“Winners”, each a “Winner”) will be selected in a random drawing by

representatives of Sponsors from all eligible Entries received, for a total of three hundred and fifty (350) potential winners during the Sweepstakes Period. Sponsors will make two (2) attempts to notify potential Winners via direct message or tweet to each potential Winner's Twitter account in order to obtain potential Winner's mailing addresses. **Sponsors may share potential Winner's name and contact information with Sweepstakes Entities and/or any prize provider, as applicable, if necessary.** Potential Winner may be required to execute and return an affidavit of eligibility, release of liability, and, except where prohibited, publicity release (collectively, "Sweepstakes Documents") within ten (10) days of such notification. Each Prize will consist of either: a Fandango Promotional Code valid for two movie tickets\* ("Prize 1") or *The Secret Life of Pets* merchandise pack ("Prize 2"). There will be two hundred (200) Prize 1 packages and one hundred and fifty (150) Prize 2 packages awarded. Prize is awarded "as is" with no warranty or guaranty, either express or implied by Sponsors. Prize is subject to certain terms and conditions as specified by issuer. "Prize 1" and "Prize 2" will collectively be referred to herein as "Prize" or "Prizes".

**DISPUTES: THE SWEEPSTAKES IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN NEW YORK, NEW YORK. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JUDICIAL ARBITRATION AND MEDIATION SERVICES, INC., IN ACCORDANCE WITH ITS STREAMLINED ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN NEW YORK. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN THE COUNTY OF NEW YORK. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.**
